Guidelines for Biennial and Themed Conferences

- 1) The Biennial conference should be ideally 2 days long (and no more than 3 days), in order to avoid limited attendance by colleagues, and to maximise its importance as a place for the whole community to meet and discuss;
- 2) Conferences should ideally have just one keynote speaker, and certainly no more than 1 keynote speaker per day;
- 3) The Biennial conference will have a PGR poster competition, to which all PGRs are invited to participate;
- 4) CV clinics and employability sessions for PGRs and ECRs will continue to take place at the Biennial Conference (PGRs and ECRs should sign up in advance for the CV clinic);
- 5) All conference and panel organisers should encourage mixed sessions in terms of seniority (from PGRs and ECRs to more senior colleagues) and gender;
- 6) Registration fees should always be available also for single days.
- 7) PG fees should be no more than 60% of the full fee. Alternatives must be discussed with and approved in advance by the SIS Exec (please contact Clodagh Brook)

The Society's Gender Policy for Conferences

Conferences and events organised by the SIS will respect the following norms:

- a. as far as possible there will be a balance in the number of male/female speakers and session chairs;
- b. single-sex panels will be avoided wherever possible;
- c. panel chairs will be briefed by you on how to ensure inclusive and balanced discussion;
- d. where there is more than one keynote speaker efforts will be made to ensure gender balance.
